

MEMORANDUM
ABOUT RAPPORT AND COOPERATION

LLP "Velesstroy", hereinafter referred to as the "**Enterprise**", registered at the address: 060000, Republic of Kazakhstan, Atyrau region, Atyrau, Azattyk Avenue, house 48, b-floor, business center "Suleimen Tower", BIN: 980740006185, represented by the Deputy General Director Marko Bosich, acting on the basis of Power of Attorney No. D. BKZ-52-11 dated 01.01.2022, on the other hand, and **NAO "Kazakh National Research Technical University named after K.I. Satpaev"**, hereinafter referred to as the "University", represented by a member of the Board - Vice-Rector for Academic Affairs Zhautikov Bakhyt Akhatovich, acting on the basis of Power of Attorney No. 9 dated February 1, 2022, on the other hand, hereinafter jointly referred to as The "Parties", and individually the "Party", have entered into this Memorandum of Understanding and Cooperation, hereinafter referred to as the "Memorandum" as follows:

1. Subject and purpose of the Memorandum

- 1.1. Subject and purpose of the Memorandum The subject of this Memorandum is the cooperation between the Parties on the practical training of qualified specialists in the profile of the Company's activities.
- 1.2. The purpose of this Memorandum is to provide the industry with professional personnel and improve the quality of training of specialists.

2. Directions of the Memorandum

2.1. The main areas of cooperation between the Parties are:

- participation in coordinating the topics of term papers, final works of students (students, undergraduates, doctoral students) and scientific research of the University, taking into account the needs and capabilities of the Society;
- conducting practical training (internships) for students, employment of graduates, taking into account the capabilities of the Enterprise;
- - development of scientific mentoring on scientific research projects and promotion of the integration of science and innovative production in the interests of the socio-economic development of the country;
- - training on master's and doctoral programs and advanced training of employees of Velesstroy LLP.

3. Terms and conditions of the Memorandum

3.1. The Parties hereby agree as follows:

Company:

- assists in the passage of industrial practice (internship) of students / graduates of the University in the specialties specified in Appendix No. 1;
- provides support for initiative research and development of students, undergraduates, doctoral students and young scientists of the University as scientific supervisors and consultants;
- assists in strengthening the ties between the University and the company in the course of joint events;
- to carry out meetings with students of the University in order to conduct a presentation of the company, master classes from Top managers, trainings, etc.

University:

- creates conditions for the training of qualified specialists (undergraduate students, undergraduates and doctoral students) with an appropriate theoretical base, including in accordance with the requirements set by the Company for internships (internships);
- forms among young people a steady interest in the application of theoretical knowledge in practice;
- coordinates the interaction between the Society and students of the University on the issues of internships (internships).

4. Validity and procedure for termination of the Memorandum

- 4.1. This Memorandum comes into force from the date of its signing by both Parties and is valid from "" 2022 to "31" December 2022.
- 4.2. The implementation of this Memorandum is carried out by the Parties on the principles of equality, openness and integrity.
- 4.3. By mutual agreement of the Parties, this Memorandum may be amended and supplemented by additional agreements that are integral parts of this Memorandum.
- 4.4. Each of the Parties may terminate the Memorandum ahead of schedule by notifying the other Party of its intention in writing 30 (thirty) calendar days before the expected date of termination of this Memorandum.
- 4.5. Termination of the Memorandum does not cancel the obligations of the Parties under contracts and agreements concluded by the Parties at the time of the validity of the Memorandum.

5. Additional terms

- 5.1. The Parties separately disclaim that the conclusion of this Memorandum does not bind the Parties with any legal obligations, does not entail the emergence of financial obligations, and in the event of any obligations, the conclusion of separate agreements by the Parties is required.
- 5.2. The Parties also proceed from the fact that no actions within the framework of this Memorandum should infringe any powers and rights of any of the Parties.
- 5.3. Each Party will bear its own expenses arising from the fulfillment of the terms of this Memorandum, except as otherwise specified in the relevant agreements.
- 5.4. Each Party will not make public statements without prior agreement with the other Party regarding their cooperation under this Memorandum.
- 5.5. This Memorandum is concluded in 2 (two) original copies, one for each Party.

6. Anti-corruption requirements

- 6.1. The parties refrain from committing, inciting to commit actions that violate or contribute to the violation of the legislation of the Republic of Kazakhstan, including in the field of combating corruption, do not pay, do not offer to pay and do not allow the payment of any money or valuables, directly or indirectly, to any persons, to influence the actions or decisions of these persons in order to obtain any improper advantage or to achieve other improper goals.
- 6.2. When fulfilling their obligations under the Memorandum, the Parties do not carry out actions qualified by the legislation applicable for the purposes of the Memorandum, as giving/receiving a bribe, commercial bribery, as well as actions that violate the requirements of applicable law and international acts on combating the legalization (laundering) of illegally obtained income .
- 6.3. If a Party suspects that a corruption violation of any provisions of this section of the Memorandum has occurred or may occur, the relevant Party undertakes to notify the other Party in writing.
- 6.4. In a written notice, the Party must refer to the facts or provide materials that reliably confirm or give reason to believe that a corruption violation of any provisions of this section of the Memorandum by the Party has occurred or may occur.
- 6.5. The Party that received the written notification is obliged to conduct an investigation and submit its results to the other Party, or send materials to the appropriate state authorized body, and inform the other Party about it.
